**Purpose**

This form is for use by EROs only. An ERO must complete this form when:

- the ERO is e-filing 2020 Form IT-370-PF, *Application for Automatic Extension of Time to File for Partnerships and Fiduciaries*, and
  - the payment of the balance due on the e-filed Form IT-370-PF is being made by electronic funds withdrawal through an approved e-file software package.
- OR**
- the ERO is e-filing 2021 Form IT-2106, *Estimated Income Tax Payment Voucher for Fiduciaries*, and
  - the payment of the balance due on the e-filed Form IT-2106 is made by electronic funds withdrawal through an approved e-file software package.

**Do not use** this form to authorize payment on Form IT-370-PF or Form IT-2106 if an electronic funds withdrawal is **not** used or if you are filing Form IT-370-PF or Form IT-2106 on the Tax Department’s website.

**Instructions**

Complete this form only when you transmit an electronically filed Form IT-370-PF or IT-2106 **and** payment is being made by electronic funds withdrawal. Note that an electronic signature can be used as described in TSB-M-20(1)C, (2)I, *E-File Authorizations (TR-579 forms) for Taxpayers Using a Paid Preparer for Electronically Filed Tax Returns*.

**Important:** You do not need to complete Form TR-579.3-IT for Form IT-370-PF extension requests if no payment is required, a paper check is used for the payment, or you are using the Tax Department’s Internet extension application.
